

ADDITIONAL PRODUCT INFORMATION

The Tolcylen™ Anti-Fungal Solution is the first product of its kind to combine FDA approved Anti-Fungal medication with Nail Renewal and Cosmetic ingredients. The Tolcylen™ Anti-Fungal Solution falls under the FDA category of a combination drug and cosmetic product. The anti-fungal ingredient is classified as an OTC (over the counter, non-prescription) medication. The cosmetic ingredients are classified as inactive ingredients even though they can improve the nail appearance in fungal nails and other nail conditions. By eliminating all heavy seed oils and artificial preservatives found in most other OTC anti-fungal products, the patent pending, low surface tension and molecular weight cosmetic ingredients are able to rapidly penetrate into the nail plate.

ACTIVE INGREDIENTS:

The active ingredient in Tolcylen™ Solution is Tolnaftate. Tolnaftate is approved to kill and prevent the fungal infections of the skin around the nails. It has not been approved by the FDA to penetrate into or be effective on the nails or scalp. Tolnaftate has been shown to be effective on athlete's foot, which is a fungal infection of the skin that can cause nail fungus and re-infect cleared nails.

INACTIVE/COSMETIC INGREDIENTS:

The Tolcylen™ Anti-Fungal Solution cosmetic ingredients include Urea, Lactic Acid, Undecylenic Acid, Jojoba Oil and Vitamin E. Clinical studies and scientific data on these ingredients have shown them to be effective on improving the appearance of fungal and non-fungal nails. Urea can rapidly thin and rehydrate painful, thickened and dehydrated nails. Lactic Acid has been shown to improve the

appearance of discolored nails. Undecylenic Acid acts as an emulsifying agent and lowers the surface tension of the other emulsified ingredients, so they can more effectively penetrate into nails. It is also been shown to be an effective organic preservative. Jojoba Oil is actually a wax ester that has molecular properties almost identical to the sebum which covers and is present under the front your nails. It can replace sub normal supply of sebum to your nails. Vitamin E has been shown to improve overall nail appearance in compromised nails.

USING THE TUBE/BRUSH TIP APPLICATOR:

The screw cap should be removed and the brush tip pointed downward towards the toe or finger nail area. Before the initial use, it should be primed by squeezing the tube until the brush starts to become saturated. Once the brush is saturated you can apply to the area along the edges, under the front and/or onto the nails. Squeeze the tube again when the brush starts to become dry. Consult your physician to determine where and when to apply the solution for your specific treatment. The patented Tolcylen™ tube and TruFlow™ brush tip applicator is leak proof when the cap is securely placed back onto the tube. When replacing the screw cap, make sure to fasten tightly to prevent leakage and evaporation. For best results the product should be stored at room temperature.

WHAT TO EXPECT:

Typically, it can take up to 12 months for complete nail regrowth. However, the Tolcylen[™] Anti-Fungal Solution cosmetic ingredients have been clinically proven to improve nail appearance starting in as little as 2 weeks.
